This is a summary of the annual report for the TEAMSTERS LOCAL 170 HEALTH AND WELFARE FUND, (Employer Identification No. 04-2219623, Plan No. 501) for the period January 1, 2014 to December 31, 2014. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Teamsters Local 170 Health and has committed itself to pay the following types of claims incurred under the terms of the plan.

INSURANCE INFORMATION

The plan has contracts with Hartford Life & Accident Insurance Company, Ace American Insurance Company, and Hartford Life & Accident Insurance Company to pay the following types of claims incurred under the terms of the plan.

All life insurance, stoploss and accidential death & dismemberment claims

The total premiums paid for the plan year beginning January 1, 2014 and ending December 31, 2014 were \$330,967.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$30,244,066 as of December 31, 2014 compared to \$27,948,117 as of January 1, 2014. During the plan year the plan experienced an increase in its net assets of \$2,295,949. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$29,266,369. This income included employer contributions of \$27,294,475, employee contributions of \$1,008,404, realized losses of \$25,401 from the sale of assets and earnings from investments of \$810,291. Plan expenses were \$26,970,420. These expenses included \$1,848,576 in administrative expenses and \$25,121,844 in benefits paid to participants and beneficiaries.
